A contract for caretaking of common property with a body corporate (i.e. gardens, swimming pools, pathways etc). What are management rights? - Hynes Legal One is the "Management Rights" clause, which states some of the general rights that management has. The other is the "Recognition" clause, which states the rights of the Union and the obligation of management to deal with the Union. Most often the Recognition clause is at the beginning of the contract and reads something like
